SECTION 13: WARRANTY INFORMATION

The complete, written KUHN Limited Warranty Conditions are clearly stated by the various companies of the KUHN Group and are part of the documents provided to the Retail Purchaser of KUHN machines. The purpose of this Section 13 is to summarize some of the important Limited Warranty provisions that an authorized dealer should be aware of and provide basic information on warranty processes, allowances and KUHN's Technical Improvement Programs. The following is only a summary of KUHN's written Limited Warranties. See KUHN's applicable Limited Warranty for each Product for the full terms and details. For your convenience, the Kuhn North America and Kuhn Krause limited warranties are located at the back of this GTC. The limited warranty is provided by KUHN to the original retail purchaser of new Agricultural Equipment manufactured by KUHN and purchased from authorized KUHN dealers.

13.1 KUHN LIMITED WARRANTY

A. LIMITED WARRANTY:

KUHN warrants that Equipment will be free from defect in material or workmanship under normal use and service during the warranty period. KUHN's sole obligation under this limited warranty, and Purchaser's exclusive remedy, is to repair or replace, at KUHN's election, without charge and at the place of business of a dealer authorized to handle KUHN Equipment, any Equipment or portion of the Equipment which KUHN determines to be defective.

B. LIMITED WARRANTY PERIOD:

For the Equipment, the warranty period is twelve (12) months beginning on the date of delivery by an authorized KUHN dealer to Purchaser.

C. REPLACEMENT SERVICE PARTS AND NON-WARRANTY SCALE REPAIR:

Replacement service parts are subject to the following special warranty terms (but are otherwise subject to all limitations, exclusions and restrictions in this limited warranty):

Replacement Service Parts	90 days from date of sale or balance of Equipment warranty period if longer ¹
Rake / Tedder rotor gearboxes	12 months from date of sale ¹
GMD / FC replacement cutterbars	

¹ For all service parts sold after the applicable Equipment warranty period, KUHN will not reimburse Purchaser for expenses incurred in repairing or replacing defective service parts including, without limitation, labor expenses.

For Scales: KUHN recommends that all dealers have scale loaners available for customer use. However, KUHN does offer rental indicators to Dealers for their customers' use. Rentals are not covered by scale manufacturer warranties or by KUHN warranty. Rental indicators are invoiced at a set rate for the first 21 days of use and a per day charge over 21-days (21 day minimum charge). Contact KUHN - Brodhead, WI for rates. Repair charges will apply for any damage done to the indicator while it was being used.

D. EXTENDED WARRANTY CONDITIONS:

In addition to the limited warranty period, the following extended warranty terms are offered on certain components (but are otherwise subject to all limitations, exclusions and restrictions in this limited warranty):

ProSpread Commercial Spreaders (PSC, PXL) have only the standard 12-month limited warranty on side and front panel rust-through and floor breakage.

E. PURCHASER'S RESPONSIBILITY:

It is the purchaser's responsibility to perform the recommended maintenance at the intervals outlined in KUHN's Operator's Manual. Purchaser will be responsible for any service call and/or transportation of equipment to and from an authorized dealer's place of business. Prior to using or permitting use of the equipment, a purchaser shall determine the suitability of the equipment for the intended use, and the purchaser assumes all risk and liability whatsoever in connection therewith.
